

Rate: Prices of individual items should be inclusive of all taxes and duties including, Customs Duty, Excise Duty, etc. It should also include Supply, Installation, Testing, Commissioning, packing, forwarding, transport, etc. GST shall be extra. Rate should be quoted only in Indian Rupees (INR) on DOOR Delivery Basis at various LIC Guest houses Jaipur, Rajasthan. , Inclusive of all the Charges. Note : No other charges would be payable by the LIC except mentioned in BOQ.
2.
