Terms & Conditions for the Disposal of old Cables and Patch Panels

1. All the rates shall be filled up in figures as well as words in English only without fail.
2. The rates and amount against each item shall be filled up only in the tender form issued to the tenders.
3. The tenders should be submitted in sealed covers. Open tenders will be rejected.
4. The tender shall be duly signed by the competent person.
5. No paper sheet shall be detached from the tender document issued to the tenderers.
6. Any overwriting in rates or any change and/or alteration without attestation is liable to culminate in the outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
7. The tender shall be liable for rejection if any one of the above said requirements are not complied with.
8. Date of Inspection for the tender items is 21.03.2024 and 22.03.2024 from 11:00 AM to 4:00 PM.
9. In any case it will be presumed that the bidder has inspected and verified the material before quoting.
10. The weight/quantity of the items is approximate and there could be +/- 10% difference in the weight/quantity mention. The vendor has to considerate the same and quotes the price on "**As is where is basis**" of the items. In no case will the final amount will be reduced.
11. The tender will be rejected if the rate is not above the MRP as decided by the competent authority.

13. The items shall be sold to the H1 bidder i.e. the bidder that offers Highest Price.
14. The bidder shall lift the material from the premises after payment of full amount within the prescribed time limit, failing which they will cease the right to lift the material and the payment deposited shall stand forfeited.
15. No permission will be given to segregate the items, the material should be collected as it is. No partial quantity in one time will be issued.
16. The bidder shall clear the material out of the premises at its own arrangements/ cost, etc.



17. LIC reserves the right to reject / partly accept, any or all offers without assigning any reasons whatsoever.
18. The tender will be awarded to the highest bidder for total value, and not on individual line items.
19. The highest bidder is required to deposit the estimated total value within 5 working days by NEFT or by DD payable at Mumbai after declaration of highest bidder, failing which the tender will be scraped.
20. The bidder emerges as highest bidder has to lift all items within stipulated time, if the bidder fails to lift the items within stipulated time the tender will be scraped.
21. The materials will be allowed to be lifted between 10:00 am to 5.00 pm on any working days. No picking, choosing or sorting will be allowed in the premises for the disposal lots.
22. Labour, transport and other arrangements will have to be made by the purchaser complying with the laws at their risk, cost and responsibility. Any compliance with the laws of the land is responsibility of the purchaser. LIC of India will not be held responsible for any loss/accident at the site, of manpower deployed by the bidder. Also, in case of any damage occurring to the building/infrastructure during lifting of material, the contractor will have to make good the same before leaving the site.
23. The person authorized by the purchaser will be allowed to take delivery.
24. No items once disposed to the successful bidder shall be taken back by LIC.
25. Taxes and duties that may be levied by the Govt. will be extra as applicable and shall be borne and deposited by the highest successful bidder before lifting of material.
26. No complaint whatsoever will be entertained after the tenders are submitted or before or after materials are lifted. No request for samples or inspection after submission of the tender will be accepted.
27. Bidder has to seal and signed every page of the tender documents in their Letter head.
28. The H1 bidder will have to submit the PAN card, GST certificate and Bank Details.
