### **ELIGIBILITY CRITERION**

#### [For all Category]

1. The Manufacturer / Firms/Printers /Suppliers /Vendors /Dealers/Service Providers should be in the continuous profession for at least last 3 years (Self-attested copy of up-to-date Trade license /registration certificate with renewal of Municipality/Corporation/statutory authority etc. for 3 years must be enclosed)

2. Annual turnover should be up to
a. Rs. 5 lakhs in each of the last 3 financial years for small jobs,
b. Rs. 5 lakhs and above to Rs.25 lakhs in any 3 financial years for medium job
c. More than Rs. 25 lakhs in any 3 financial years for big jobs (attach for last continuous 3 years – IT returns).

 Fully Audited PL A/C & Balance Sheet, along with IT Returns in case of medium and big firms/company/trader/suppliers is must).

4. The **The Manufacturer / Firms/Printers /Suppliers /Vendors /Dealers/Service Providers** must be in the approved panel of at least 3 reputed firms out of which at least one should be a Government/Public Sector or Govt. undertakings. (enclose letter of approval of the empanelment or any other supporting documents).

5. Must submit self-attested Copy of :

a) The PAN CARD issued by Income Tax Authority and Bank Account Pass Book / Bank .

b) GSTIN registration No., with GSTIN certificate/ payment receipt, wherever applicable.

c) ESIC Registration No., EPF Registration No., Factory Registration No., NSIC Registration No., wherever applicable.

6. Medium and big firm/suppliers must possess Office, E-mail address and telephone Nos.
