1. The Tender Forms will be available from **07.10.2024 to 22.10.2024** Between 11 am and 3 pm on week days (excluding holidays, All Saturday and Sundays) in our Divisional Office, Deepshikha Road, Vishwanath Nagar, Begusarai or it can be downloaded from lic website (www.licindia.in)
2. The last date for submission of filled in tenders (both technical and financial bids) is **22.10.2024 up to 3 pm**. The offers received after the last date and time mentioned above will not be considered.

4. The Technical Bid will be opened on **22.10.2024 At 3:30 pm** in the presence of bidders or their authorized representatives who may like to be present. After preliminary scrutiny of the technical bids, verification of credentials, site inspection of the shortlisted premises offered by them, assessment of the offers, the financial bids of only those bidders, whose offers are found suitable to the Corporation, will be opened at later date. The date of opening of Financial bids will be intimated in writing to those bidders whose offers are found suitable.
5. The tender form consists of the following documents, i.e.

This tender consists of two parts, viz, Technical Bid Including Instructions to Bidders Terms and Conditions and Financial Bid Containing expected price only. Separate Technical and Financial bids are to be submitted for each proposal. The Technical Bid, Financial Bid and the Earnest Money Deposit (EMD) should be sealed in envelopes. The use of envelopes will be as under :

- I) **Envelope Marked as I** : The duly completed Technical Bid be put in this envelope and sealed.
- II) **Envelope marked as II** : The duly completed Financial Bid put in this envelope and sealed.
- III) **Envelope marked as III** : The DD or Bankers Cheque for “ Earnest Money Deposit” and “ Cost of tender document” or the M.R. of the required value be put in this envelope and sealed.

Term & Condition

1. The terms and conditions along with the instructions will form part of the tender to be submitted by the tenderer to LIC of India, termed as Corporation.
2. Tender which is received on account of any reason whatsoever including postal delay etc after the expiry of time and dated i.e. **22.10.2024** at 3 pm fixed for submission of tenders shall be termed as “**LATE**” tender and not to be considered. Such tender shall be returned to the concerned party without opening the same.
3. All the vendors/bidders are requested to submit the tender documents (Technical Bid and Price Bid) duly filled in with the relevant documents/information at the following address.

4. All columns of the tender documents must be dully filled in and no column should be kept blank. All the pages of the tender documents are to be signed by the authorized signatory of the tenderer. Any over writing or use of white ink is to be duly initialed by the tenderer. The Corporation reserves the right to reject the incomplete tenders or in case where information submitted/furnished is found incorrect.
5. In case the space in the tender document is found insufficient, the vendors may attach separate sheets.
6. The offer should remain valid at least for a period of three months to be reckoned from the date of opening of “ Technical Bid.”
7. There should not be any deviation in terms and conditions as have been stipulated in the tender documents. However, in the event of imposition of any other condition, which may lead to a deviation with respect to the terms and conditions as mentioned in the tender document, the vendor is required to attach a separate sheet marking “ list of deviations.”
8. The Technical bids will be opened on (22.10.2024 at 3:30 pm) in the presence of bidder at our above office. All bidders are advised in their own interest to be present on that date, at the specified time.
9. Corporation reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
10. Canvassing in any form will disqualify the tenderer.
11. The short listed vendor will be informed in writing by the Corporation for arranging site inspection of the offered premises.
12. Income-Tax and Statutory clearances shall be obtained by the vendors at their own cost as and when required. **All payments to the successful Landlord/Vendor shall be made by Neft /cheque only.**
13. Property should be situated in good Residential/commercial area of the town/city with congenial surroundings and proximity to public amenities like bus stop, banks, markets, hospitals, schools, etc.
14. The title report proving ownership and clear marketability is to be enclosed.
15. The premises shall be preferably freehold. Alternatively, if it is leasehold, in case of such premises, details regarding lease period, copy of lease agreement, initial premium and subsequent rent shall be furnished.
16. There should not be any water logging inside the premises and surrounding areas,
17. The premises should have good frontage and proper access.
18. The lesser shall have no objection to the lessee, the lesser/s shall provide suitable space for installation of Gen set without any extra cost to the lessee.
19. Latest certificate from the competent authority of having paid all the updated relevant taxes indicating the details of the property offered for leasing out to LIC.
20. Offers received from Government Bodies/Public Sector undertakings/State Housing Boards etc..will be given preference.

21. The particulars of amenities provided /proposed to be provided in the premises should be furnished in the technical bid.
22. The Lesser shall arrange for repairs and maintenance, white washing/color washing/OBD painting/painting to doors, window etc. as and when informed by lessee.
23. The bids will be evaluated on techno commercial basis giving weight age to the equivalent aspect in various parameters like locations, distance from local railway station, amenities available, exclusively nearby surroundings, proneness to water logging/flood etc. quality of construction, efficacy of the internal layout of premises and lay out of buildings in the complex.
24. Tenders from intermediaries or brokers will not be entertained
25. The premises offered should be in good and ready to occupy condition (If building is under construction, then it should be handed over within 2 months of award of bid). The owners of the premises will have to hand over the possession of premises within 60 days after the acceptance of their offer by the department.
26. It may be noted that no negotiation will be carried out, except with the lowest tenderer and therefore most competitive rates should be offered
27. **Rate per sft. On carpet area** : . The Carpet area rate shall be inclusive of basic rent plus all proportionate statutory charges (i.e. all taxes/cess present and future house tax, property tax, and municipal taxes etc except GST, if any) maintenance charges and service charges like society charges etc. the rent will be paid from the date of taking possession of the premises. Nothing extra will be paid other than the monthly lease rent. Lease rent is payable in the next following month before 7th of every month.
28. **Lease Period** : Preferable period of lease will be 15 years with 3 years lock in period and minimum notice period of four months from either side for termination of agreement. The lease period will be extendable for mutually agreed period & escalation in rent.
29. **Addition & Alteration works** : During the period of tenancy, if the lessee desires to carry out any addition & alternations works at its own cost as per the requirement of the Dept. lesser will permit the same on the existing terms and conditions and obtain any permission if required, from the local authority, lesser will also provide space for display signboards without any extra cost.
30. **Lease Agreement** : Will be with the owner & rent will be paid to respective owner.
31. **Income Tax** : Will be deducted at source at prevailing rate.
32. **GST** : GST if any will be payable to owner.
33. **Registration & stamp duty charges** : will be shared equally between the lesser and lessee(50:50).

34. Deposit :

- i) The payment shall be made only after occupation of the premises or after the possession is handed over to us.
 - ii) No advance should be made for a building under construction or for putting up an extension to an existing building or to construct a new building on a vacant plot of the landlord.
- 35. Possession of Premises :** within 60 days from the date of receipt of acceptance of offer/letter. The premises have to be painted & should be in habitable condition while taking over the possession.
- 36. Water Supply :** The owner should ensure and provide adequate supply of drinking water and water for W.C. & Lavatory throughout the lease period at his own cost.
- 37. Electricity :** The building should have sufficient electrical/power load sanctioned and made available to the Corporation.
- a) If required, additional electric power will have to be arranged by the Lesser/offer at his/their cost from the energy suppliers.
