It was informed that we shall consider the suggestion and update on the revised dates , if any decided.

2) In order to standardize the hotel facility and facilitate fairness in quotes and based on the discussions with the representatives of Tour Operator, it has been decided to do hotel booking in the following five star hotels at Athens:
