GENERAL TERMS AND CONDITIONS

Unless mentioned otherwise in following clauses, the terms & conditions of service Providers for Housekeeping Services in Sales Training Center, LICI,Link Road,Cuttack in force at the time of opening of this tender, shall be applicable where context so requires. The tender will be accepted on the basis of the amount quoted for providing House Keeping Services.

(A)SALES TRAINING CENTERE, LINK ROAD, CUTTACK:

Sales Training Center, LICI,Link Road,Cuttack- 753012 is Training Centre of the Life Insurance Corporation of India which has been providing training to LIC Officials mainly covering the offices falling under jurisdiction of Cuttack Divisional Office,Cuttack. The STC Campus comprises of an Administration Block & Hostel Building. It has been provided with electricity and water facililities. The Hostel Building consists of THIRTY (30) 3 bedded rooms, TWO (02) 2 bedded rooms, one recreation room and one reception lobby etc. Ours is a Training Institution where the trainees will be mainly LIC Officers, employees and Agents.

As mentioned in Page No.2 of this Tender Draft, all the applicants are advised to examine the proposed work physically during the office hours before submitting their Price Quotations.

(B) LIST OF JOBS UNDER HOUSEKEEPING SERVICES OF THE STC HOSTEL

- a) Opening & Closing of Hostel gates
- b) Receiving the participants
- c) Entry Form fill up and allotment of rooms
- d) Change and supply of fresh bed sheets and pillow covers in the room
- e) Verification & checking of items supplied in the room
- f) Supply of mosquito repellant in the room
- g) Relieving of the participants
- h) Maintenance of room keys
- i) Change of Bed Sheets, Towels and Pillow Covers etc. in every 3 days and arrange for their washing by approved dhobi in case change of occupants
- j) Switching on/off the bulbs, tube lights, CFL Lamps, TV, AC etc. and all other electrical fixtures/equipments which require to be switched on/off. The Agency shall ensure that the lights and fans which are not required are put off in the entire STC campus.
- k) Maintenance of Stock Register and all items of the hostel list of which would be provided by STC to the approved service provider / firm at the time of signing the contract agreement.
- (C) TERMS & CONDITIONS FOR HOUSE KEEPING SERVICES AT STC
 - 1. The applicant (Tenderer /Agency) should have experience in Housekeeping/maintenance services for not less than three years and should be registered to carry out this type of job as per the prevailing laws of the state. Necessary documentary proof to substantiate such certification and experience must be attached with the quotation.

- 2. The number of employment is one or two is to be decided bythe Competent Authority discussing with awarded bidder/ the firm for smooth functioning of the jobs as mentioned. (B) However, the firm must have an EPF, ESI Registration No. and premia towards ESI contribution of employees and employees monthly wage paid records must be produced to our office every month before settlement of Bills.
- 3. The applicant must not have been at any time declared insolvent or in respect of the applicant no insolvency proceedings/attachment proceedings is pending in any court of law and he should not be convicted for any offence by any authority and should not be declared defaulter in respect of payment of minimum wages, PF ,ESIC and other statutory liability in respect of the workmen.
- 4. Preference shall be given to those who have experience of rendering similar services in Public Sector Undertakings/Central Government.
- 5. The applicant shall comply with all the requirements of labour laws having all licences/approvals/permissions to carry on the business House Keeping services.
- 6. The rates to be quoted shall be inclusive of all i.e.providing House Keeping services inclusive of all statutory payments, taxes, charges, levies etc., if any ,excluding GST, which will be payable as per prevailing rules. Minimum wages applicable as on date of publication of the Tender advertisement (Central or State whichever is higher), Taxes, Charges, Levis etc., must be taken into consideration when quoting.
- 7. No other increase in the amounts quoted by the selected Tenderer shall be entertained on any account during the duration of the contract and renewal period, if any expect for changes in applicable minimum wages and related statutory payments and that would be payable/reimbursable as and when varies.
- 8. No corrections in the quotation would be accepted.
- 9. Any tender not complying with requirements/conditions either wholly or partially shall be liable for rejection.
- 10. The Sr. Divisional Manager, LIC of India, Cuttack Division, Cuttack reserves the right to change the relevant dates, to accept any or reject all of the applications, or cancel all tenders without assigning any reason whatsoever.
- 11. The contract shall be for a period of 03 (Three) years. The Competent Authority may renew the contract up to one year on existing terms and conditions, subject to satisfactory performance, at the sole discretion of the competent authority i.e. Sr.Divisional Manager, LICI, Cuttack Division.
- 12. During the currency of this agreement, the contractor/Service provider agency may, by giving a three months' notice to the competent authority can terminate the contract. Sr. Divisional Manager may terminate the contract by giving one month notice to the Contractor/Service Provider Agency. However, for any breach of terms and conditions by the tenderer, the competent authority can cancel or terminate the contract at any time during the validity period of tender.
- 13.If in the course of execution of this contract by the Agency any minor or major damage is caused by the "Agency" or his workmen to the person property of STC, after joint investigation by the STC and the Agency/Tenderer any claims arising there from shall be recovered/settled and dealt with directly by the Agency and the Agency shall render all assistance and co-operation to STC if any enquiry is held thereon.
- 14. The Agency shall not have any tenancy rights by virtue of entering into an agreement with STC. The premises and its facilities will be utilized by the Agency only for the purpose as described in the agreement during the currency of the contract.



- 15. The Agency will be responsible for safety and security of all the internal and external items of furniture, fixtures, equipments etc. Cleanliness is the essence of this Contract and sole responsibility of the service provider. The Agency has to provide Uniform and Identity Cards to the deployed workmen at their own cost, a copy of such Identity Card is to be submitted to the undersigned at the time of signing the contract agreement.
- 16. The Agency will be responsible for and security of all internal and external items of furniture, fixtures, equipments, etc.
- 17. The Agency shall return to STC all materials and equipments supplied by STC, as per inventory ,on termination of the contract for any reason whatsoever with normal reasonable wear and tear, failing which the Agency shall be responsible for the cost of the same as shown in the inventory of STC. Any article misplaced or damaged by the Agency has to be replaced by Agency.

(F) PENALTY CLAUSE:

Any deficiency of service may attract suitably penalty as decided by the Competent Authority or by the committee formed by him during the contract period.

(G) IRDA GUIDELINES:

"In terms of provisions of Section 33(4) of the Insurance Laws (Amendment) Ordinance, 2014, Insurance Regulatory and Development Authority of India (IRDAI), if it considers expedient to do so, may direct any person hereinafter referred to as "Investigating Officer", to make an investigation as specified under Sec. 33(1) or carry out an inspection as specified under Section 33(2) of the Insurance Laws (Amendment) Ordinance, 2014, who may examine an oath any Manager, Managing Director or Other Officer of the service provider or contractor where the services are outsourced by LIC of India."

(H) ARBITRATION:

All disputes of any kind what so ever arising out of or in connection with this Contract shall be referred to the Sr. Divisional Manager ,LIC of India, Divisional Office, Nuapatna ,Cuttack for settlement of dispute and the verdict will be final and binding.

ADDITIONAL CONDITIONS

- 1. Earnest Money Deposit: Rs 2000/- (Rupees Two thousand only)(Refundable). EMD will not carry any interest.
- 2. Security Deposit: The qualified Vendor has to deposit Security Deposit of 5 % of the approximate wages for 03 Years before we place order for the above work.
- 3. Sealed quotations attune to the above terms and conditions should reach the undersigned either or by registered post on or before 03.30PM on 06.05.2025. Any quotation received after the specified time and date shall be treated as cancelled. Your authorized representative may be present at the time of opening of tender by our committee on the very same day about at 4.00PM.
